From Doyle at ArtFx – September 2021

Attached are a couple of rough mockups for the signage that we had discussed. The signs would be fabricated out of aluminum, have a painted finish, 3" square aluminum poles painted to match. Cost for signs similar to this would be approximately \$2350 for the 8 ft. sign and \$1500 for the 5 ft sign. Cost for installation would be an additional \$795 for a total of \$4645 after installation.

The City plans to pay for this project to help improve our building signage and identification:

For the window lettering at City Hall, we still need to confirm that the lettering that is currently on the window is in fact a removable etched glass film and not actually etched into the window. The cost for removing the existing lettering and replace with something like the attached proof would cost \$350-450 after installation (depends a bit on the time required to remove the existing lettering).
